TAX NOTICES

CURRENT TAXES ARE DUE DECEMBER 31ST, IN THE YEAR THEY ARE LEVIED.

Please find enclosed the 2024 tax notices. A discount for early payment of taxes is being offered. Discount rates are as follows: 5% paid by June 30th, 3% paid by July 31st, 2.5% paid by August, 2% paid by Sept. 30th, 1.5% paid by Oct. 31st, & 1% paid by Nov. 30th. No discount is offered for payments made in December. A 10% per annum, added on January 1st applied to the total taxes that remain unpaid as of January 1 of the year in which the penalty is being applied. **This discount does not apply to education tax.**

If making payment by mail and to receive full discount offered for the month in which the payment is intended, please ensure that your envelope is **post marked** in the month for which you are making a payment. The books will be closed following the last day of the month and no late payments will be accepted under any circumstances. Post marked payments will be processed for the month of the post marked date. The method of payment is by cash or cheque or e-transfer payment to villageofdrake@sasktel.net or through the Conexus Credit Union EFT. Post-dated cheques and/or monthly payments are also accepted.

What Does the Village Do with Your Tax Dollars?

Tax revenue is **crucial** to the operation of the Village. Listed below are some of the areas where municipal tax dollars are spent, highlighting the areas that have seen a cost increase in 2024.

- **Police & Protective Services** – fees increased in 2024.
- **Garbage & Recycling** – Village moving to curbside pickup in 2024.
- **Insurance** – fees increased 2024.
- **Planning & Development** – the Village is to acquire the land for Well No. 4, estimated at approximately \$15,000.
- **Equipment Maintenance** – the Village's grader and 4-Ton Truck require substantial repairs and/or replacement.
- **Employees** – New Public Works Foreman Certification training
- **Snow Removal** – cost increased as the village needed to hire extra equipment and operators to keep up with heavy snowfall in March.
- **Water services** - Capital cost of new Reverse Osmosis. Increase to the cost of repairing water line breaks.
- **Due to the Re-evaluation completed in 2023, many properties taxable assessment decreased, therefore reducing the Village's tax revenue.**

If you rent out property, you will receive a copy of your tenant's utility bill. Unpaid utility bills may be added to the tax roll of the property owner after Dec. 31.

All dogs and cats within the Village are required to be licensed? Pet Licenses can be purchased at the Village Office. In exchange for the licensing fee, we provide you with a pet tag and take a description of your pet to keep on file, along with your contact information.

The Village of Drake is moving to curbside pickup!! REACT tags will no longer be required for garbage pickup. Expect your new REACT curbside bin to arrive in June/July 2024.

Grass clippings and garden refuse will be collected from back alleys every Monday morning from April 15th until November 4th. Grass clippings and leaves MUST be in CLEAR bags or should be in an open container which can be loaded onto the truck and returned to the owner once emptied. Bags/containers must not weigh more than **44 pounds (20 kg)**. Pick up includes small piles of tree branches, corn stalks etc., (less than a **½ ton truckload**) and should be laid in the same direction,
